Applying a Filter: Before a Filter Before a Filter When editing an image, you can apply a filter. To apply a filter in Photoshop Elements, choose Filter • Filter. (If Photoshop Elements has a small icon, such as a little green square, by the Filter menu, then the filter is already applied.) When you apply a filter, the actual effect of the filter is applied to the image. For example, you can create a black and white image using a Black & White filter. However, the subject or background in the image will not be converted to black and white. Instead, it will remain the same color as it was before the filter was applied. However, if you want to reduce the color in an image, you can do that with a Hue/Saturation filter. This is a great filter to use when you want to change the color in a photo but you don't want to change the colors in the subject or the background. The Hue/Saturation filter makes the color in the image less saturated. Applying a Filter: After a Filter After a Filter A filter can look different when it is applied to an image. Some filters alter the subject, or the background. Sometimes, the filter changes the overall color in the image, or changes it in a limited area. NOTES [1] A lease which contains the value given or the residual value, whichever is greater, will not necessarily give the lessee a greater deduction. The purpose of the rule, which has been the same for some time, is to prevent the owner of the business from increasing the amount of a loan from the bank by leasing the business which he has purchased. Thus, the lessee may not increase the amount of the bank loan by taking an assignment of the lease with a higher value. The principle underlying this rule is that a taxpayer cannot achieve a tax benefit on an income producing asset merely by assigning it to another. A situation in which the statutory purpose is not served by the rule has been described as one in which "if the value is fixed by agreement of the parties it may be disregarded. Thus, for example, where the lessor and lessee agree on a different value, or where, without agreement as to a value, the lease is rescinded and the property is returned to the lessor, the value of the lease is not to be regarded." 1 E.
